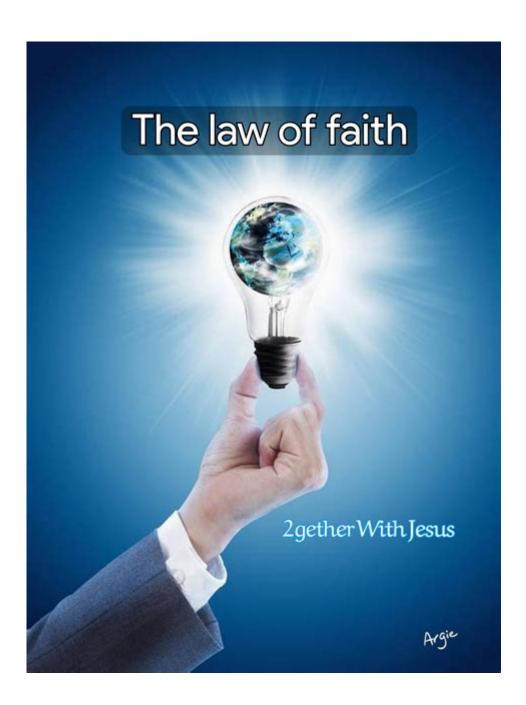
# What Is The Law Of Faith
