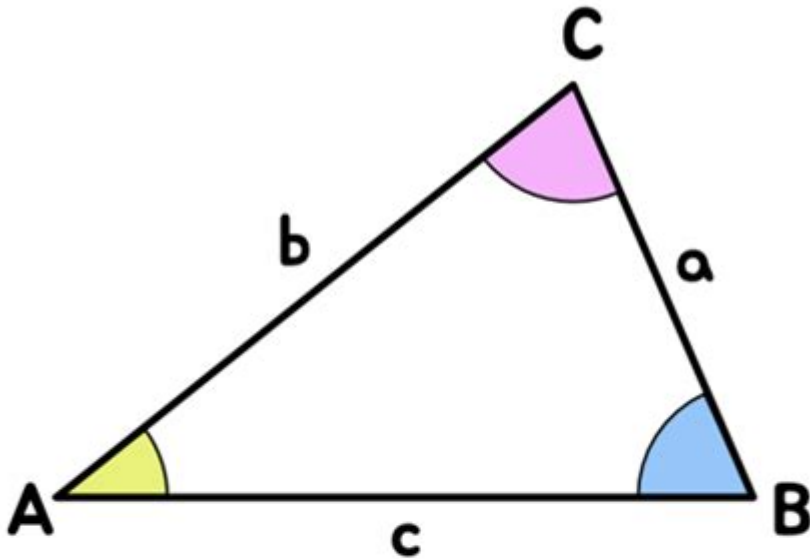


# What Is The Law Of Sin
