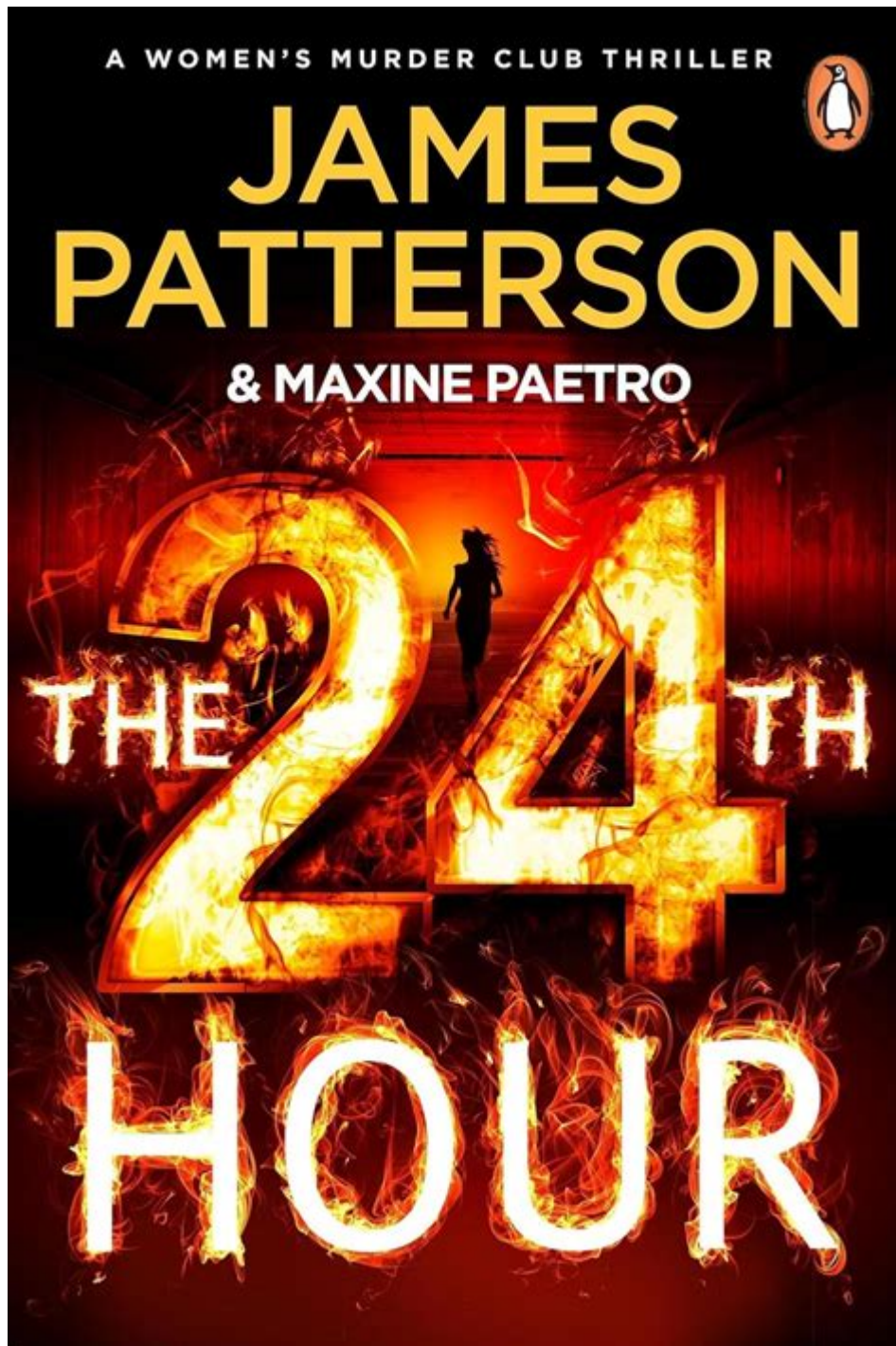

4. YUKI CASTELLANO: A TALENTED DEFENSE ATTORNEY, YUKI PROVIDES A DIFFERENT PERSPECTIVE ON CRIME AND JUSTICE, OFTEN CHALLENGING THE GROUP'S ASSUMPTIONS AND STRATEGIES.
